

PROCESS FLOW FOR PROVISIONAL ACCREDITATION PHASES OF PARTP

1. APPLY FOR LEVEL 1 PAP 0

Submit the following on or before deadline-last working day of March, at close of office

- Letter of Intent addressed to the PBOG Chair and/or Application Form PARTP Form IA1 (Appendix B3)
- Complete documentary requirements listed in PARTP Form IA (Appendix C2)

If complete, a **Letter of Acceptance** to PAP 0 with recommendations will be sent to the institution after approval of the PBOG meeting *en banc*. The RTP has a maximum of 3 years to recruit 1-3 residents.

2. APPLY FOR LEVEL 1 PAP 1

Submit a Letter of Application for PAP 1 as soon as with 1-3 recruited 1st year residents

1. Once all recommendations are complied with and upon approval of PBOG *en banc*, a **Letter of Approval for PAP 1 INTERIM** will be given to the RTP.
2. The PBOG approval date will be the first day of the RTP's first interim year and will be known as PAP 1 INTERIM.
3. PARTP Visit 1 will be on the 4th to the 6th month of the interim year.
4. CREED First Visit will be on the 7th to the 9th month of the interim year.
5. PARTP ACCREDITATION VISIT FOR PAP 1 will be on the 10th to the 12th month of the interim year.

PAP 1 Accreditation NOT granted

Must correct deficiencies and follow recommendations. Submit a letter for PARTP RE-ASSESSMENT VISIT within 1 year

If all requirements are met, a **Certificate for PAP 1 Accreditation** will be issued. PAP 1 Accreditation commences 12 months from the date of Approval of PAP 1 INTERIM and is valid for 3 years.

If all requirements are NOT met for PAP 1 Accreditation, **remain** in PAP 0 for a max of 3 years

3. APPLY FOR LEVEL 1 PAP 2

Submit a Letter of Application for PAP 2 as soon as the 1st year resident/s has/have been promoted to 2nd year and with 1-3 newly-recruited 1st year residents

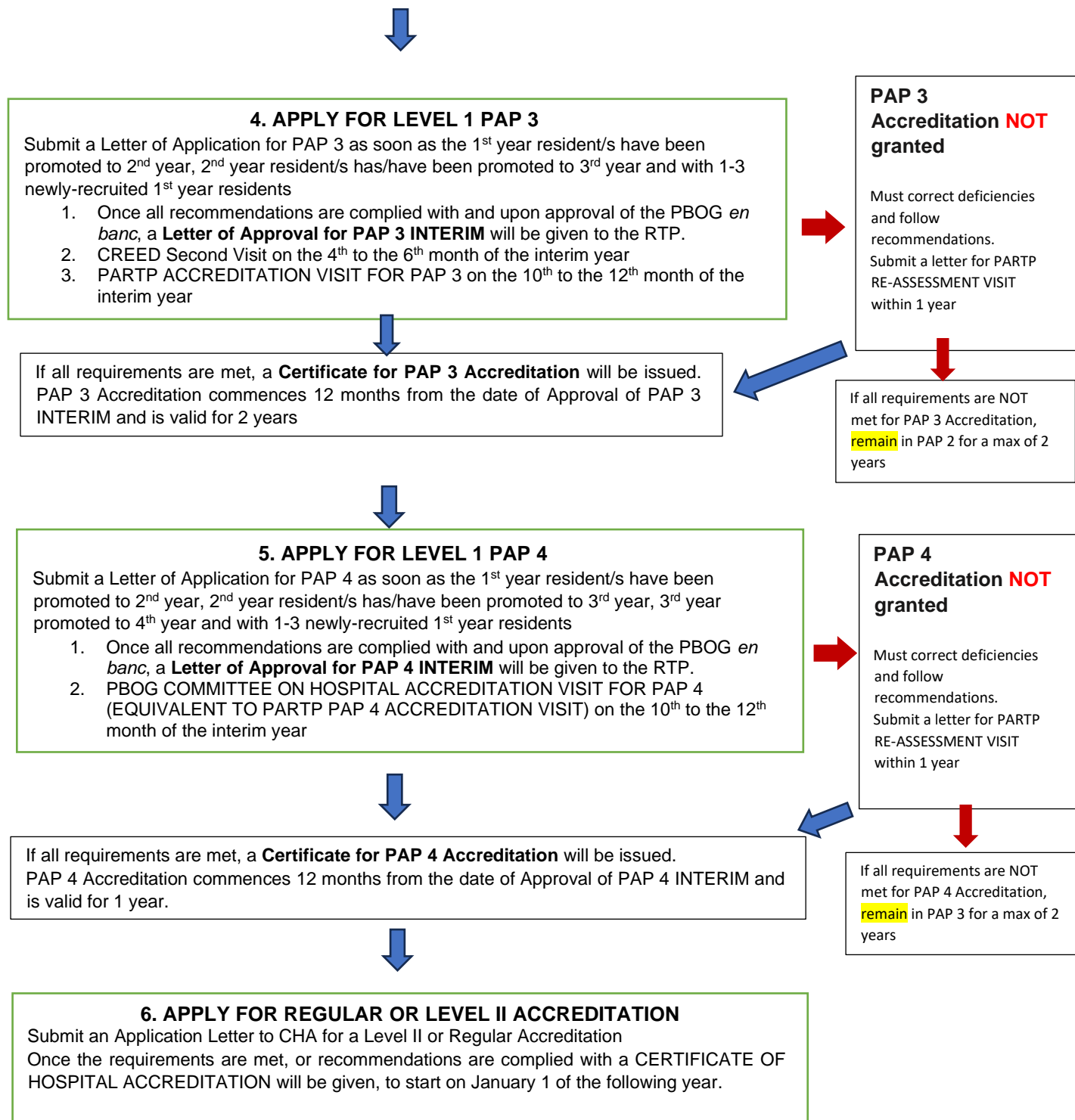
1. Once all recommendations are complied with and upon approval of the PBOG *en banc*, a **Letter of Approval for PAP 2 INTERIM** will be given to the RTP.
2. CREED Second Visit on the 4th to the 6th month of the interim year
3. PARTP ACCREDITATION VISIT FOR PAP 2 on the 10th to the 12th month of the interim year

PAP 2 Accreditation NOT granted

Must correct deficiencies and follow recommendations. Submit a letter for PARTP RE-ASSESSMENT VISIT within 1 year

If all requirements are met, a **Certificate for PAP 2 Accreditation** will be issued. PAP 2 Accreditation commences 12 months from the date of Approval of PAP 2 INTERIM and is valid for 2 years.

If all requirements are NOT met for PAP 2 Accreditation, **remain** in PAP 1 for a max of 3 years



Example: (Assuming that yearly accreditation is obtained)

PAP 0 JUNE 1, 2022; JULY 1, 2022 Approved to start PAP 1.
PAP 1 Interim - JULY 1, 2022 - June 30, 2023 ----- 1. 1st yr resident
PAP 1 accredited - JULY 1, 2023-June 30, 2024 PAP 2 Interim - - - - 2. 2nd yr resident
PAP 2 accredited - JULY 1, 2024-June 30, 2025 PAP 3 Interim - - - - 3. 3rd yr resident
PAP 3 accredited - JULY 1, 2025-June 30, 2026 PAP 4 Interim - - - - 4. 4th yr resident grad: July 1, 2026
PAP 4 accredited- JULY 1, 2026- June 30, 2027
Accredited for LEVEL 2 Jan 1, 2027
Graduate may apply for July 2027 Part 1 (Written) Exam
